

SWIFT Services

As a Coupa *SWIFT Services* customer, you are a member of the SWIFT Standardized Corporate Environment (SCORE), the world's most powerful banking network. To protect this network and all its members, SWIFT requires everyone to adopt strict safeguards as part of its Customer Security Programme (CSP). These safeguards are checked annually and from 2021 must also be approved by an independent assessor.

In order to ensure your successful compliance with CSP, Coupa offers you a special service called *SWIFT Services*. A team of trained experts is dedicated to support you and guide you through the SWIFT CSP to raise your awareness for cybersecurity and comply with the mandatory SWIFT Security Controls.

SWIFT Services is an annual fee-based service covering the CSP assessment along with the token management.

What business challenges are addressed?

Companies, especially within their treasury departments, use the SWIFT network as a central communication channel for payments and account statements. However, there are several obligations that come along with the SWIFT connection e.g., the SWIFT setup¹ must be fully functional and compliant with the regulations at any time. Fulfilling these obligations requires in-depth knowledge and can be time-consuming.

Each SWIFT customer is responsible to meet the requirements of the Customer Security Programme (CSP) and to submit the KYC Self-Attestation on time, being complete and compliant with the Customer Security Control Framework (CSCF Framework).

Failure to undertake an assessment along with keeping an outdated assessment published could be reported to supervisors by SWIFT and made visible to counterparties in the same manner as a failure to timely attest or the publication of a non-fully compliant attestation.²

The Coupa *SWIFT Services* supports you to complete these tasks and be compliant with all regulatory requirements.

What are the conditions to use SWIFT Services?

- Your treasury management system is hosted in the Coupa Cloud.
- Your SWIFT tokens are stored and managed by Coupa on your behalf.
